Time for a Review

As I write this, we are in the midst of a beautiful fall in Colorado. We have all enjoyed many spectacular (and wet) rides over the last few months. Sadly, we have also experienced the tragic loss of Mike Walker who was one of the Assistant Directors of the Colorado District. In spite of GWRRA's commitment to rider training and safety, senseless tragedies like this can happen. Perhaps this is our reminder of how quickly life can change, and the importance of advance planning in our lives.

I am a financial and estate planning advisor in my "civilian" life. I have personally seen the benefits of good estate planning, and sadly what can happen when people fail to plan. As winter approaches and our riding days become fewer, this may be the best time to review those "must have" legal documents:

Durable Power of Attorney for Health Care. Identifies who would make medical decisions on your behalf if you were unable to do so yourself.

Durable Power of Attorney for Assets. Identifies who would make financial decisions for you if you were unable to do so yourself.

Nomination of Conservator. Identifies who would be responsible

for your person if you become incompetent.

Appointment of Guardian. Identifies who would be guardian of your minor, incompetent or disabled children upon your death.

Living Will. States your wishes regarding life support if life is being sustained solely by artificial means. Will. A legal declaration of a person's wishes regarding the distribution of his/her property or estate after death. A Will is probated (administered) by the court system.

Living Trust. Similar to a Will in that it is a legal declaration of a person's wishes regarding distribution of his/her property or estate after death. However, a Living Trust avoids the court process and can provide estate tax savings. People favor Living Trusts over Wills when they have children under the age of 25; an estate of over \$1 million (this includes life insurance); have a handicapped child or a child whose spending habits concern them; or have children from a previous marriage.

Other Tips

Review any disability and life insurance policies at least every couple of years to make sure your family is adequately covered in the event of accident or death. Carry a card in all vehicles that contains emergency contact information, a list of prescription drugs being taken, and other applicable medical information. Since my wife, Nancy, doesn't always take her purse, we have a laminated copy of our driver's licenses, insurance cards and other important information in our GoldWing trunk.

Send a copy of your Durable Power of Attorney for Health Care to the person you have selected to make medical decisions on your behalf if you should become incapacitated. It is also a good idea to keep a copy of this document in all vehicles.

So many times we prefer not to think about these things and avoid the subject. It's not always a pleasant thought. My hope is that this article will motivate us all to do a planning review. Rider Education

As we are now into the colder months of the year I thought it appropriate to post a reminder about tire pressures and the effect of temperature on same.

Stamped on the outside of many of your tires is a recommended tire pressure range. (At least an upper limit.) For longest tire life it is my recommendation that you strive to keep them at the higher limit of those recommendations (regardless of what your motorcycle owner's manual might say to the contrary.) Further, this pressure should be determined while the tires are cold - meaning, have not been used for a couple of hours.

Time and outside temperature effect the pressure within your tires. It is NORMAL for a tire to lose about 1 pound per square inch (psi) per month. Outside temperatures affect your tire pressure far more profoundly, however. A tire's pressure can change by 1 psi for every 10 degrees Fahrenheit of temperature change. As temperature goes, so goes pressure.

For example, if a tire is found to have 38 psi on an 80-degree mid-summer day, it could lose enough air to have an inflation pressure of 26 psi on a 20-degree day six months later. This represents a loss of 6 psi over six months and an additional loss of 6 psi due to the 60 degree temperature reduction.

At 26 psi, your tire is severely under inflated and dangerous!

There is nothing wrong with your tire if it behaves like this, of course. What is being illustrated here is that you MUST check your tire pressure on a regular basis (about once a week is reasonable) and to be particularly aware of it on cold days.

A great success due to wonderful members like we have in GWRRA and the terrific help we had from Mark, Ron & Marsha, Jennie and Ginny.






