Day One: From Colorado Springs, CO to Goodland, KS - 182 miles

The Run for the Wall started in Rancho Cucamonga, CA. I left Colorado Springs, CO, on 22 May 2010 around noon to join the group in Goodland, KS. The weather was about 80 degrees. My plans were to camp all the way to D.C. I had already pre-registered on-line to make the process for registering for the next day a lot easier. I was assigned to Platoon 4. After the rest of the bikers arrived, we ate pulled pork and beans for dinner at the Armory that evening. That night, we had a choice to sleep in the Armory or put up a tent and sleep outside. So that I would not have to put up a tent, I took the shortcut and slept inside. I should have put up the tent and slept outside on the soft grass.

Day Two: Goodland to Junction City, KS - 285 miles
I ate breakfast at the Armory again. I had pancakes, sausage, and bacon. I attended the mandatory riders meeting (happens every morning) and then I was on my way to Oakley, KS, with the group. I ate lunch in Oakley. I had hamburgers, hot dogs, beans, chips, and something to drink. My final stop for the night was in Junction City. People lined the street as we entered town with lots of American flags being held by the citizens of the town. The parade leads us to the memorial for a ceremony. After the ceremony, the American Legion provided us with dinner. They served us roast beef with gravy, corn, mash potatoes, a salad, and some bread. WOW, what a meal and it was very tasty. I put up my tent and slept in Sertmo Park with the rest of the group that were camping.

Day Three: Junction City to Wentzville, MO - 341 miles

I had breakfast at the American Legion and ate eggs and hash browns served by the soldiers of Ft. Riley KS. As a group, we had to stop and refuel several times because some of the smaller bikes have small fuel tanks. From state line to state line of Missouri, we had a state police escort. It was pretty awesome not having any vehicles on the highway. It made many people upset because we held up traffic, oh well, they will get over it! Our lunch meals were provided by the citizens/support group of the city that we visited. The final stop for the day was at Wentzville, MO, with a parade as we entered town. They also paid for our gas here. As a side note, the town of Wentzville has supported the Run for the Wall for 22 years at the same location. This is amazing and so was the food served at dinner. I camped at the VWF, which made it easier for breakfast the next morning.

Day Four: Wentzville to Corydon, IN - 294 miles
For breakfast at the VFW, I
 ate biscuits and gravy, eggs and hash browns. After the morning meeting, our first stop was at the Veterans Memorial in Wentzville. From here, I went to another memorial at Jefferson Barracks. Our final stop for
the day was at Corydon, IN, at the Harrison County Fairground where dinner was provided by the Moose Lodge, American Legion and others. The group had provided a fish fry for us. I camped out at the fairground, which was convenient for all the campers. While inspecting my bike that evening, I noticed I
 had a headlight out on the left side, low beam. Last year I had the right side go bad. Because it was such a small town, the nearest Honda dealer was either in Evansville, IN, or Lexington, KY, to the best of my knowledge at the time. All I really needed was an automotive store and I could get a replacement bulb. After driving around, I found an Auto Zone, purchased the bulb and installed it in about fifteen minutes.

$\frac{\text { Day Five: }}{244 \text { miles }}$ Corydon to Hurricane, W.VA 244 miles We made several stops to visit Veterans Hospitals and Memorials. Another long day of driving, but it was all worth it. As we were on the highway into town, there was a helicopter giving us an escort coming into town. We had another parade into town. The helicopter landed in the parking lot of the Wave Pool for a couple of hours. The final stop for the day was at Hurricane, W.VA, at the Wave Pool in town. They served a spaghetti dinner for everyone. If you were camping, you could pitch your tent at the park.

Day Six: Hurricane to Rainelle/Lewisburg W.VA - 131 miles

After breakfast, I was on the road to Charleston, W.VA, to hear the governor speak to the Veterans. We all parked our motorcycles in front of the capital and took a group picture which is on the W.VA web site. My motorcycle is in the middle of the picture and I'm about the third row up. http:// www.wvgov.org/viewpicture.aspx? albumid=696\&pictureid=3743 Go to the official W.VA website, then select governor website on upper left of screen. Then go to photo gallery. The picture was taken on 27 May. This was one of the better days because the miles were shorter and I didn't have to ride in a group or side by side for the entire day. WOW!!! What a change! I got to see some scenery instead of the license plates of the bikes in front of me. After Charleston, I took route 60 to the town of Rainelle, W.VA. We had a parade through town with and stopped at the Rainelle Elementary School. All of the towns on route 60 came out to greet us as we drove through the towns. There was a lot of American spirit in those small towns. Now the students were waiting for us to arrive to autograph their books or t-shirts. I was told the children look forward to visiting with the Vets and have them sign their books or a tshirt. The children really appreciated us. We are their heroes! Veterans that were here last year brought trinkets to give to the kids. After visiting with the children and having lunch, I was on my own to proceed to Lewisburg for the night or stay in Rainelle. I chose Lewisburg because our departure was from Lewisburg the next morning.

## Run for the Wall with Earl Edwards

Day Seven: Lewisburg to Washington D.C. - 258 miles
I made it to the starting point after stopping at McDonald's for breakfast. This would be our last morning meeting. The ride to Arlington would be another tough ride because there will be no police escorts on the highway or in the city. We made a few fuel stops before arriving in Arlington, VA. We were all happy that we made the trip safely. From this point, I went to check in at Fort Belvoir where I had room reservations.

Day Eight: Arlington National Cemetery/ Lincoln Memorial

The next morning I met the group at 0630 at the Holiday Inn parking lot for the ride to the Arlington National Cemetery. All of the FNG’s (Fun New Guys/Gals) are allowed to ride their bikes through the rear gate of the cemetery. The Run for the Wall organization is the only group that is allowed to enter this gate. The changing of the guard is an awesome sight to see, the precision and timing is just fantastic. We spent about 90 minutes there and then the entire group left through the front gate and over the Arlington Memorial Bridge to the Lincoln Memorial for a group picture. After the group picture, I went to the Vietnam Veterans Memorial to find a name, PFC Leroy Martinez, Monte Vista, CO, door gunner on a helicopter that crashed after 11 missions 25 May 1940. I placed a plaque at his name. I did some sightseeing for the rest of the day. That evening, dinner was provided by the Arlington Assembly of God Church. Once again, we received a fantastic dinner provided by the members of this church.

Day Nine: Rolling Thunder
The participants met at the Holiday Inn at 0600 for the Rolling Thunder parade. Once everyone had gathered, we departed for the Pentagon parking lot. Once there, Road Guards guided us to park our motorcycles. They were squeezing us in side by side. There was already 6000 motorcycle in place when we arrived at 0645 . As the hours went by, there was just an endless line of motorcycles that just seemed to keep coming. While waiting for our departure at noon, I had a chance to walk over to the Pentagon Memorial. The design of the Memorial was first-class. I made it back to the motorcycle and waited for the departure. Even though the first motorcycle left at noon, I didn't leave till 1300. The Rolling Thunder Parade, 500,000 motorcycles came from all over the country. The Pentagon has three parking lots, the first two were full, and I can't speak for the third parking lot. After the parade, I went back to the hotel and met up with an old Army buddy from Korea. We had dinner and caught up on old times.

## Day Ten: Flight 93 National Memorial

Early the next morning, I headed for Stoystown, PA, the crash site of Flight 93. It was about a $31 / 2$ hour ride to the site. It is a big open field and they have started to work on the construction of the memorial. People are leaving all sorts of trinkets, medals, pins, and toys at this make shift memorial. It took two days to return home. The total trip was approximately 4200 miles. I had a tremendous amount of fun, met a lot of people, and saw a lot of great memorials.
